




3M Is Not Done Paying Out — They're Just Getting Started.

INGREDIENTS

- 3.4 oz instant vanilla pudding mix
- 2 cups cold milk
- 15-oz can
- pumpkin purée1/2 tsp cinnamon
- 1/2 tsp cinnamo
 1/4 tsp nutmeg

- In small jars or glasses, place cookie crumbs on bottom, then pumpkin mixture, then whipped topping. Repeat these layers twice and end with cookie crumbs.
- 4. Chill until ready to serve!
