#1 SELLING WEED KILLER CAUSES CANCER!

Across the U.S., thousands of people harmed by using Roundup have filed claims against Bayer AG, which bought Monsanto in 2018. Monsanto has manufactured the herbicide since 1973. EASY APPLE PIE

INGREDIENTS (Servings: 8)

- 2 (9") pie crusts
- 7 large Granny Smith apples
- 1/2 cup granulated sugar
- 1/2 cup light brown sugar
- 2 Tbs all-purpose flour
- 1 large egg, lightly beaten
- 1 Tsp ground cinnamon
- 1/8 Tsp ground nutmeg
- 1 Tbs lemon juice and zest
- 2 Tbs sanding sugar

DIRECTIONS

1. Start by preparing this flaky pie crust recipe which makes 2 (9") pie
2. Place oven rack in the center position. Preheat the oven to 400°
3. Combine sliced apples, sugar, flour, cinnamon, nutmeg, and lemon juice and lemon zest; toss to coat evenly
4. Spoon the apple filling over the bottom crust. Roll out the second disc of pie crust until it is 1/8" thick and lay it over the apple filling
5. Trim the dough along the outside edge. Seal and fold under edges.
6. Brush pie crust with the egg wash and sprinkle with sanding sugar.
7. Bake until top is golden brown and the juices bubble. Cool for 3 Hrs
